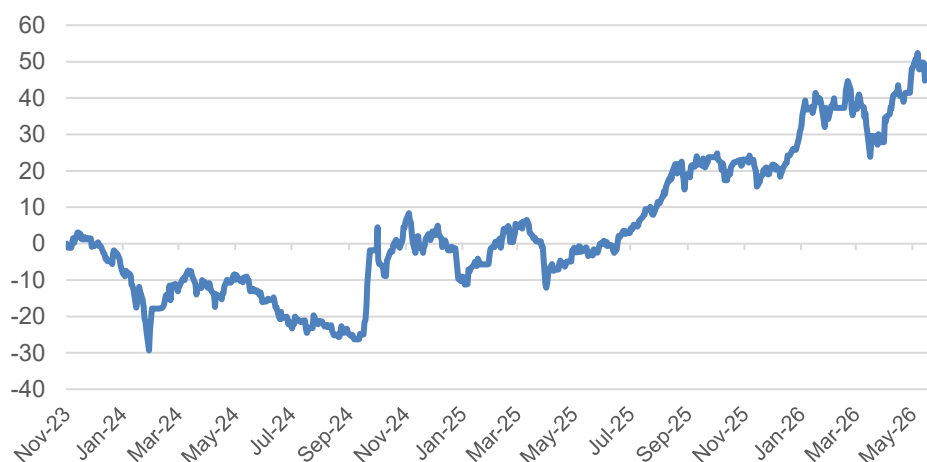
### Why CGS Fullgoal CSI 1000 ETF?

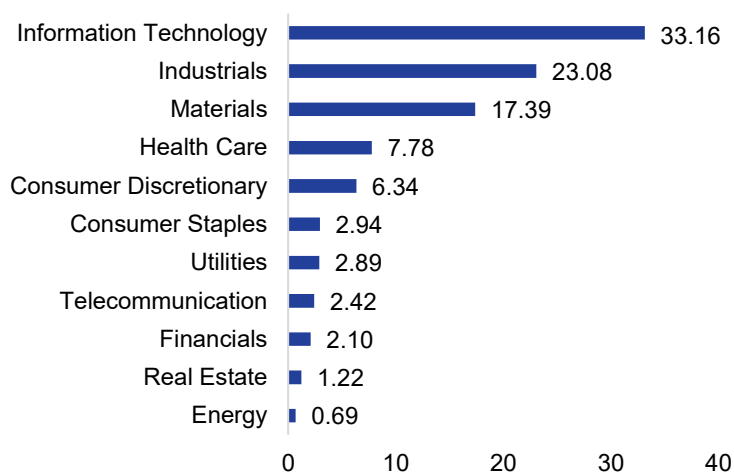
